Mr. Innes,

On August 6, 2007 a polygraph examination was administered to you at your request.

## **INCIDENT SYNOPSIS**

Mr. Innes is attempting to regain custody of his daughter, Victoria, who was taken from New Jersey to Spain by her mother who is now Mr. Innes' ex-wife. His ex-wife is now incarcerated for failing to return Victoria to the United States. She has made numerous accusations against Mr. Innes including charges that he was a drug smuggler, used false identities, is a bigamist, and tried to poison her. Mr. Innes denied those allegations and requested a polygraph examination to determine his truthfulness.

## **SYNOPSIS OF PRETEST INTERVIEW**

Prior to beginning the examination the testing procedures were explained in detail to Mr. Innes. He was advised that the test was completely voluntary and that no one could force him to take the test. He said he understood. After providing background information he gave the following account:

He married Maria Jose Carrascosa in 1999 in Spain. They had a child in 2000, Victoria Solenne Innes. The family lived in West New York, NJ.

In 2004 the couple separated. She moved to Fort Lee, NJ. In December 2004 Mr. Innes filed for divorce. Ms. Carrascosa subsequently went to Spain and filed for "nullity." The basis of her filing was accusations that Mr. Innes was a bigamist, had tried to kill her, used a false passport, had multiple false identities, and is a convicted drug smuggler. Apparently someone with the same name as Mr. Innes was arrested for drug smuggling in Spain in 1994 and is now a fugitive. He said he was never in Spain prior to 1999, and the person arrested was not him.

In January 2005 Ms. Carrascosa's parents abducted Victoria and took her to Spain. Mr. Innes has not seen his daughter, other than in Spanish courts, since Election Day 2004.

Numerous court hearings have held since that time. In the United States, state court at every level has ordered Ms. Carrascosa to return Victoria to New Jersey. She refused, fled, was captured and is now imprisoned for contempt of court. According to Mr. Innes, Ms. Carrascosa stated she would rather "sit in jail rather than turn her child over to an assassin." In Spain the courts have refused to order Ms. Carrascosa to return Victoria to New Jersey.

Mr. Innes denied the accusations made against him. He stated he wanted to undergo a polygraph examination to prove he was telling the truth.

At the conclusion of the pretest interview we took a short break for question formulation. When the examination resumed the test questions were carefully explained to him. He said he was comfortable with each question so the collection of charts commenced.

### **COLLECTION OF CHARTS**

A Stoelting CPS II computerized polygraph instrument was utilized. A Utah Format Modified General Question Test was administered consisting of three charts. The following relevant questions were asked:

*Did you ever try to poison Maria? A: No*

*Did you ever falsely represent your identity? A: No*

*Were you ever married before March 1999? A: No*

*Are you the person arrested for smuggling in Spain in 1994? A: No*

## SYNOPSIS OF POST-TEST INTERVIEW

Mr. Innes did not provide any additional information in the post-test interview.

## CONCLUSION

A careful analysis of the polygraph charts reveals the following:

The CPS II scoring system determined a score of .9392. This score is well within the truthful range.

A standard three point scoring system determined a score of +7. This score is above the threshold required for a determination of truthful. Research by the United States Department of Defense Polygraph Institute indicates highest accuracy when cutting scores of +4/-6 are utilized.

Due to the lack of significant physiological reactions to the relevant questions it is this Examiner's opinion that Mr. Innes was *truthful* when he answered the relevant questions on his polygraph test.
